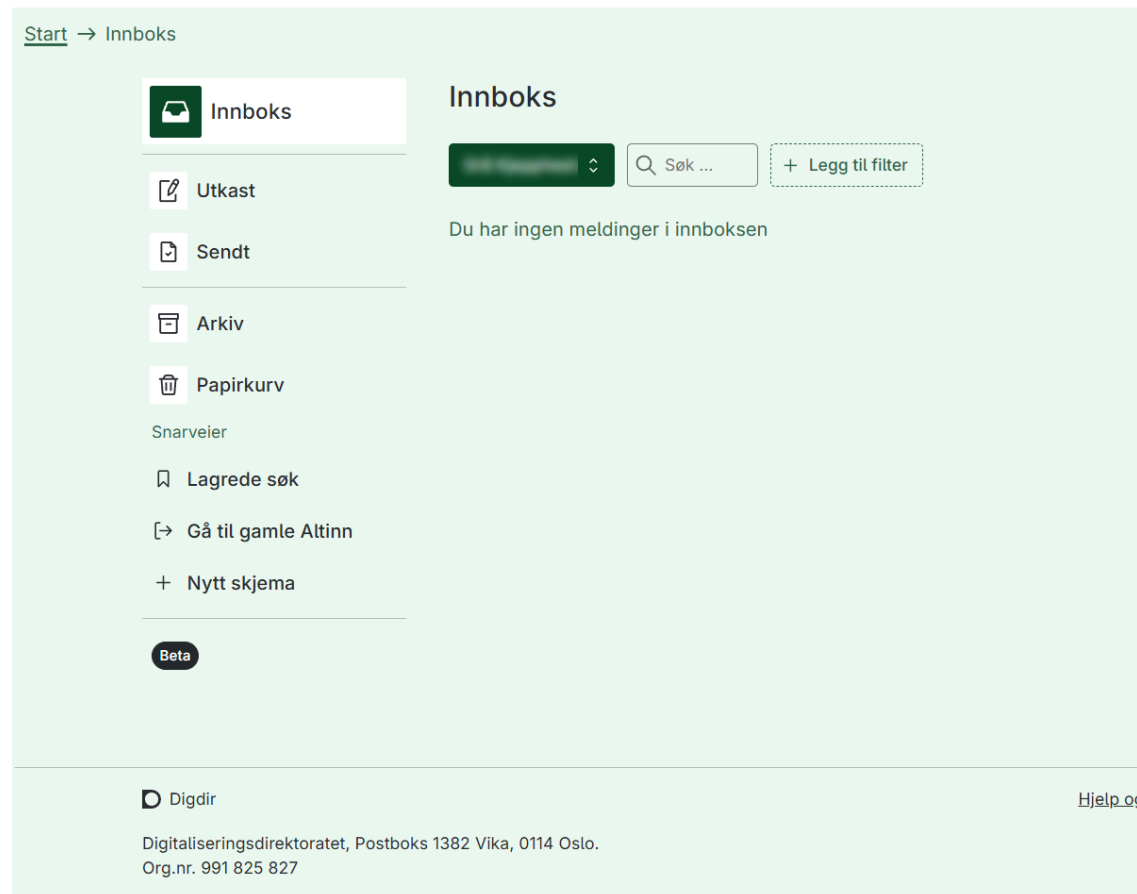
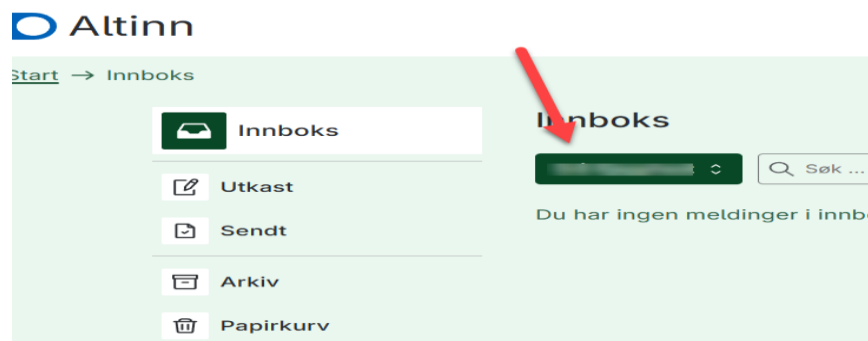


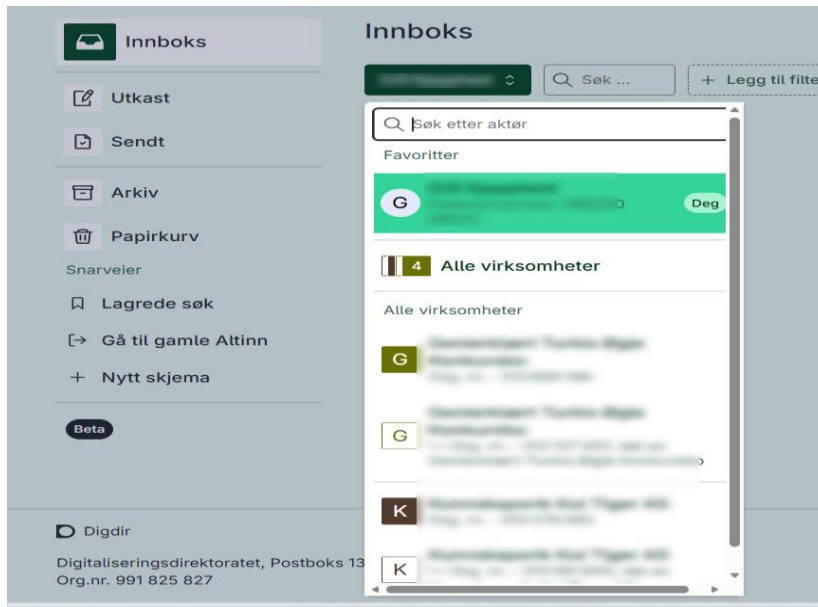
Declaration overview user guide

Log in to Altinn and get an overview of all available units for your business.



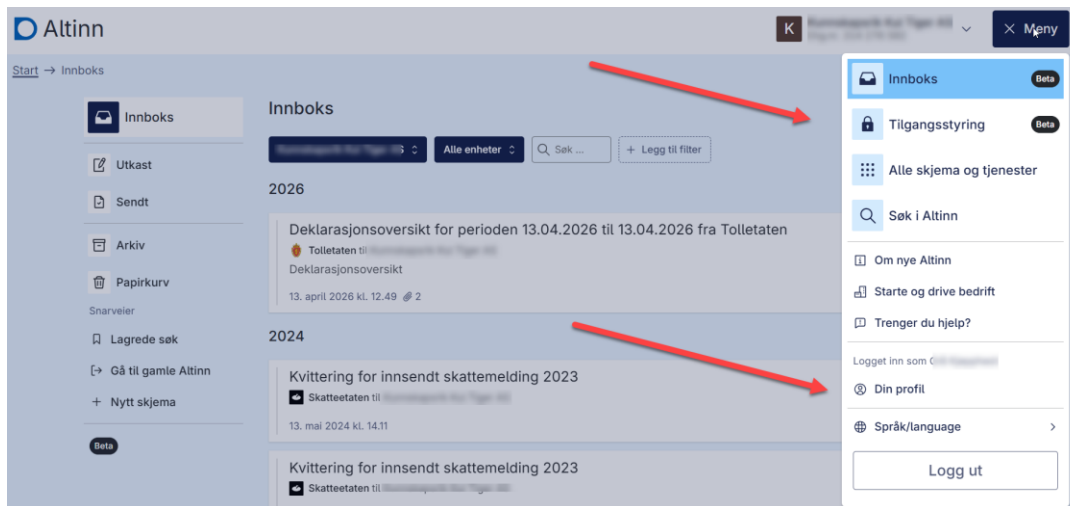
An overview of which businesses you have access to can be found here:



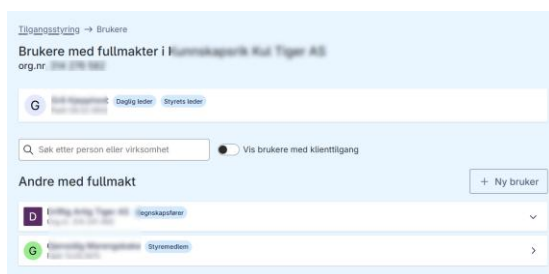
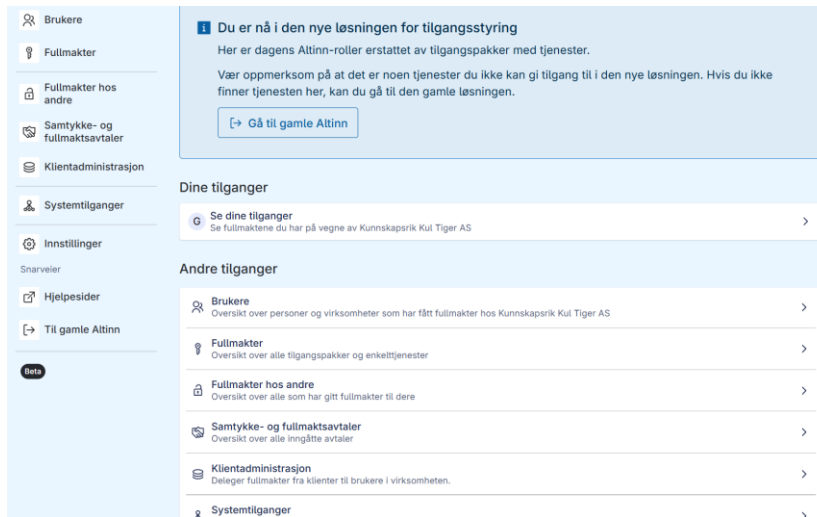


The declaration overview and notification are sent to the business that has had imports or exports, regardless of whether this is registered on the main unit or sub-unit, and the overview will also be available under the main unit.

The menu button on the right shows the available options. Here you can change access and notifications, among other things.



Access control



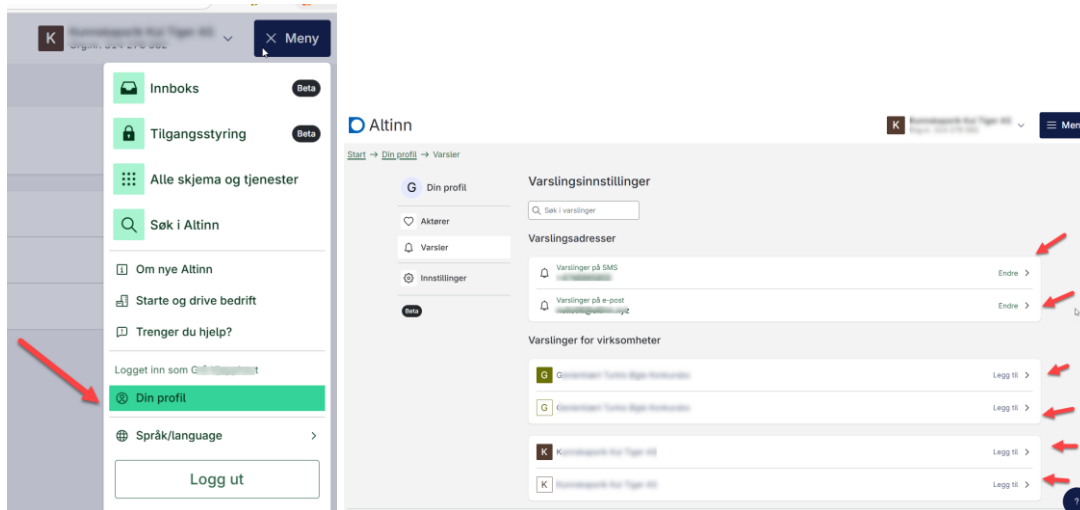
To access the service, you must either have the role "Norwegian representative for foreign entity" in the entity register, or one of the following accesses in Altinn:

- Responsible auditor
- Accountant with signing rights
- Accountant without signing rights
- Accounting employee
- Customs

The Customs access package is a package that provides access to all of the Norwegian Customs' services in Altinn.

Notification

Click on the menu and select "Your Profile"



Here you can change notifications from Altinn, click on "change" when changing your email address or phone number and enter the desired contact information. Remember to save any changes.

To receive notifications from Altinn for the declaration overview, the business must enter their email address or phone number under "Varsler" ("Notifications").

Where can I find the declaration overview?

In the inbox, there is an option to display messages for all units of the business, via a drop-down menu, even if the messages are in the sub-unit's inbox.

From May 1, 2026, the declaration overview will always be sent to the business that has imports or exports, regardless of whether the declarations are on a main unit or a sub-unit.

For machine download, the declaration overview must be downloaded from each individual unit's message box explicitly as it is not possible to download all messages for all units together.
